WOMMACK MILL GROUP USE GUIDELINES AND REGULATIONS

The Wommack Mill has been restored by the Fair Grove Historical and Preservation Society to preserve the heritage of our ancestors. One of our goals is to promote the Wommack Mill to the general public and to school children. In keeping with that goal, the grounds are available for weddings, family reunions and other group use.

The following are guidelines for the use of the Mill grounds:

1. All reservations are subject to approval by the Historical Society.
2. Except for when the Mill has been reserved, individuals, single families or clubs may use The Mill grounds for picnics on a “first come-first use” basis at no charge.
3. The fee for reserving the property **PER DAY** is as follows:
 - a. Mill grounds, bathrooms and pavilion \$100
 - b. Use of Kitchen facilities \$ 35
4. A cleaning deposit is required. Please send a separate check. The check will be held and returned (un-cashed) if grounds are left as found, tables returned to original location, bathrooms and kitchen clean, and trash placed in trash bins or removed from grounds. If cleanup is required by Historical Society personnel, the cleaning deposit will be forfeited.
 - a. Cleaning deposit is: \$ 75
5. Reservation includes the use of the indoor men’s and women’s restrooms.
6. If you need picnic tables for the pavilion, please let us know how many.
7. No alcoholic beverages are allowed at any time.
8. The Mill is available for tours provided arrangements are made in advance.

Thank you for your interest in the Wommack Mill. Please help us keep the Mill grounds clean and ready for the next group.
